

Terms & Conditions:

Using the online search and additional resources for potential brides and grooms, the website www.rishtabanao.in / rishtabanao.in ("Site") is an electronic web-based platform for investigating opportunities and improving outreach. RISHTA BANAQ ("Company") owns and operates it, and its registered office is located at the fourth floor of Parasar Tower Piska More, Ratu Road, Ranchi-834001 (Jharkhand).

Any and all usage of this website is contingent upon the following Terms and Conditions ("Terms"), which are acknowledged and accepted. Before using any of the Site's offerings ("Services"), all members must have read, comprehended, and agreed to the Terms listed below.
